SUBJECT: Payroll Issue Dates and Release of Payroll Warrants for Fiscal Year 2024-25

Please see the attached Schedule of Payroll Issue and Release Dates for Fiscal Year 2024-25, which includes recommended release dates for Classified and Certificated payroll warrants. The schedule will also be posted on District Financial Services' Forms webpage at the following address:

The Office of the County Superintendent of Schools recommends that all pay warrants be released on the issue date of the warrant. If the issue date falls on a weekend or holiday, it is recommended that the warrant be released on the following workday. (Holidays are highlighted in yellow.)

Pay warrants should not be presented or cashed before the issue date printed on the warrant. The San Bernardino County Treasurer has indicated that post-dated warrants will not be honored but returned to the employee's bank. Dishonored warrants will be automatically resubmitted, and individual banks, according to their policies, will most likely charge the employee for returned checks.

<u>For employees who have elected to be paid via Electronic Fund Transfer (EFT)</u>: If the scheduled payday falls on a Saturday, Sunday or holiday, the funds will be deposited by the following banking day.

We have highlighted all the payroll release dates that vary from the respective issuance date, so you can notify your employees well in advance.
